Brazil Export/Re-export/Import/Other	Replaces the forms sent with Notification to the Parties No. 1998/021 of 27 April 1998. The original is printed in black on white paper. This permit is valid as of 10 December 2006 and will be used along side the previous permit for a period of six months. Original size: 21 x 29.7 cm
China (Hong Kong SAR) – Licence to Export – Licence to Import – Licence to Introduce from the Sea – Licence to Re-export – Re-export Certificate	Replace all the forms sent with Notification to the Parties No. 2004/072 of 16 November 2004. All forms are printed in black on white paper. The previous forms are still valid until their expiry date. Original size: 21.6 x 27.8 cm
– Phytosanitary certificate	New. The original is printed in black on white paper. This form may also be used as a certificate of artificial propagation. Original size: 21 x 29.7 cm
Eritrea Export/Re-export/Import/Others	Replaces the form sent with Notification to the Parties No. 925 of 20 June 1996. The original is printed in black on white paper. Original size: 21 x 29.7 cm

<p>Kuwait Falcon passport</p>	<p>New. Passport with a blue cover. Each inside page is in colour with a reproduction of the State's coat of arms in the centre (12 pages). Original size: 12.5 x 8.5 cm</p>
<p>Mexico Export/Re-export/Import/Other</p>	<p>Replaces the form sent with Notification to the Parties No. 2002/042 of 24 June 2002. The original is printed in black on pale blue and white security paper. Original size: 21.5 x 28 cm</p>
<p>Monaco Export/Re-export/Import/Other</p>	<p>Replaces the form sent with Notification to the Parties No. 2001/024 of 16 March 2001. The original is printed in black on white paper with three copies (orange/green/yellow). Original size: 21 x 29.7 cm</p>
<p>South Africa Label for scientific material</p>	<p>New. The original is printed in black on white paper. The CITES logo and South African coat of arms are in colour. Original size: 21 x 29.7 cm</p>
<p>Turkey Export/Re-export/Import/Other</p>	<p>To avoid any confusion over which CITES permits are valid for Turkey, the Secretariat is re-sending the three valid permits. Each one has 4 copies with a diagonal stripe of a different colour on each page. This replaces the permit sent with Notification to the Parties No. 2003/087 of 16 December 2003. Original size: 21 x 29.7 cm</p>
<p>United States of America Tourist Item Sticker</p>	<p>Replaces the sticker sent with Notification to the Parties No. 2006/021 of 27 March 2006. Printed in black on white non-reusable adhesive paper. This sticker is placed on all boxes of cultivated ginseng of not more than 10 lbs (4.536 kg) that are sold in the United States as tourist souvenir items. It is valid until 31 December 2007. Original size: 5 x 10.1 cm</p>

Viet Nam – Export/Re-export/Import/Other	Replaces the form sent with Notification to the Parties No. 826 of 25 August 1994. The original is printed in blue and black on white paper. Original size: 21 x 29.7 cm
– Pre-Convention certificate	New. The original is printed in black on white paper. Original size: 21 x 29.7 cm
– Souvenir export certificate	New. The original is printed in black on white paper with one yellow carbonless copy. Original size: 21.3 x 15.8 cm
