

AMENDEMENTS TO APPENDICES I AND II OF THE CONVENTION

5. All parts and derivatives of FLORA spp. listed in Appendix II were included in Appendix II except:

I seeds, spores and pollen (including pollinia) except:

seeds of Cycadaceae spp., Stangeriaceae spp., and Zamiaceae spp.;

II tissue cultures and flasks seedling cultures;

III for particular plant species:

- a. cut flowers of artificially propagated Orchidaceae spp.;
 - b. separate leaves and parts and derivatives thereof of naturalized or artificially propagated Aloe vera;
 - c. fruits and parts and derivatives thereof of artificially propagated Vanilla spp.;
 - d. parts and derivatives, other than roots and readily recognizable parts thereof, of Panax quinquefolius; and
 - e. fruits and parts and derivatives thereof of naturalized or artificially propagated Cactaceae spp., and separate stem joints (pads) and parts and derivatives thereof of naturalized or artificially propagated Opuntia spp. subgenus Opuntia.
6. Following the adoption of the amendments set out in items 1 to 4, the following species and other taxa will no longer be listed as such in Appendix I or II of the Convention, once the amendments enter into force. Some species and taxa may, however, be included in either Appendix I or II under another taxon:

In accordance with the provisions of Article XV, paragraph 1, subparagraph (c), of the Convention, the amendments adopted at the fifth meeting of the Conference of the Parties entered into force 90 days after that meeting, i.e. on 1 August 1985, for all Parties except those which made a reservation before that date.
8. Following the adoption of these amendments a revised edition of Appendices I and II was prepared by the Secretariat. This revised edition is reproduced on pages 643 to 687 of the present Proceedings.
9. Some of the adopted amendments concern species or other taxa which were listed in Appendix III of the Convention. A revised edition of this appendix was therefore prepared by the Secretariat, which also entered into force on 1 August 1985. However, due to changes to the presentation of Appendix III made pursuant to Resolution Conf. 5.22, the edition of this appendix reproduced in the present Proceedings (on pages 688 to 695) is that valid as of 5 March 1986.
